<p>2. Declaration of Single Largest Completed Contract (SLCC), preferably similar to the procurement project at hand, completed prior to the deadline for submission of price quotation for the procurement project.</p>

Audited Financial Statements for the preceding calendar year, which should not be earlier than two (2) years from bid submissions; received by the Philippine Bureau of Internal Revenue (BIR) or its duly accredited and authorized institutions.</p> <p>FOR FOREIGN PARTICIPANTS: APPROPRIATE EQUIVALENT DOCUMENT/S ISSUED BY THE EQUIVALENT FOREIGN OFFICE</p>
<p>2. Statement of Compliance with all the Scope of Work (Design Plans) for which the Participant submitted price quotation/s.</p>
<p>3. Original or certified true copy of Latest Income and Business Tax Return</p> <p>FOR FOREIGN PARTICIPANTS: APPROPRIATE EQUIVALENT DOCUMENT/S ISSUED BY THE EQUIVALENT FOREIGN OFFICE</p>
<p>4. Net Financial Contracting Capacity (NFCC) computed based on the industry standards and practice in Italy.</p> <p>FOR FOREIGN PARTICIPANTS: APPROPRIATE EQUIVALENT DOCUMENT/S ISSUED BY THE EQUIVALENT FOREIGN OFFICE</p>

3. Participants shall also comply with the basic documentary requirements in competitive bidding or equivalent process in Italy.
